The Orange County Sanitation District (Sanitation District) is commencing preparation of a Draft Environmental Impact Report (EIR) for the Headquarters Complex, Site and Security, and Entrance Realignment Program, Project No. P1-128 (proposed Project). Pursuant to Public Resources Code Section 21165 and the Guidelines for the California Environmental Quality Act (*State CEQA Guidelines*) Section 15050, the Sanitation District is the Lead Agency responsible for the preparation of the EIR addressing potential impacts associated with the proposed Project.

The purpose of this letter and the attached documentation is (1) to serve as a Notice of Preparation (NOP) of an EIR pursuant to the *State CEQA Guidelines* Section 15082, (2) to advise and solicit comments and suggestions regarding the scope and content of the EIR to be prepared for the proposed Project, and (3) to provide notice of the public Scoping Meeting.

PROJECT LOCATION

The Project Site includes areas of demolition and the installation of fencing at Sanitation District's Plant No. 1, while the proposed headquarters building, laboratory, and associated parking structure would be located on an approximately five-acre site north of Ellis Avenue. Addresses associated with the proposed Project include: 10844 Ellis Avenue, 18368–18484 Bandelier Court, and 18429–18475 Pacific Street.

All portions of the Project Site are located in Fountain Valley, Orange County, California. For more details regarding the Project Location, refer to Figure 1: Project Location.

For the purpose of the analysis in this Initial Study (IS), Sanitation District Plant No. 1 will be identified as such, while the term "Project Site" will refer to the five-acre site north of Ellis Avenue intended to be the future location of the Headquarters Complex.

Our Mission: To protect public health and the environment by providing effective wastewater collection, treatment, and recycling.



PROPOSED PROJECT SUMMARY

The proposed Project includes demolition of the existing industrial warehouse buildings and construction of a new Headquarters Complex on the Project Site. The existing structures at Plant No. 1 that would be demolished as part of the proposed Project include the engineering, contracts, and risk-management trailers and the administration, laboratory, and Human Resources buildings. The proposed Project would include the construction of a 109,500-square-foot (sq. ft.) administration building, a 42,500 sq. ft. laboratory building, and a parking structure on the Project Site. The southern two-thirds of the administration building would be three stories and the northern one-third would be four stories, with a one-story Board Room in the northeastern corner. The laboratory would be two stories. The 2.5-story parking structure would include 360 parking spaces. Landscaping and security lighting would be installed along the perimeters of the buildings. A pedestrian overcrossing may be constructed across Ellis Avenue to connect Plant No. 1 with the new Headquarters Complex on the Project Site. An eight-foot-high block wall and security lighting would be installed along the perimeter of Plant No. 1 adjacent to Ward Street and Garfield Avenue.

PROBABLE ENVIRONMENTAL EFFECTS

Based on the IS that was completed for the proposed Project, the Sanitation District has determined that the proposed Project could result in impacts related to aesthetics, air quality, cultural resources, geology and soils, greenhouse gas emissions, hazards and hazardous materials, hydrology and water quality, land use/planning, noise, public services, transportation/traffic, tribal cultural resources, and utilities and service systems. These topics will be analyzed in the EIR, and mitigation will be developed and included in the Final EIR, if necessary, to address potentially significant adverse Project effects.
